## **ABOUT THE SCHOLARSHIPS**

The Foundation Trustees would like to thank you in advance for becoming a contributing donor and helping to foster the development of our future workforce. The scholarship awards will only be extended to the highest achieving high school students aspiring to receive a college degree in graphic communications.

Your generosity will allow us to select the most qualified students for scholarship awards from among the many applications received. The exact number of awards is based on the amount of funds raised in a given year. All funds will go directly to the students' tuition and related expenses for the school year. Awards will also be considered for the second, third and fourth year of prior award recipients, with continued academic accomplishment and graphics career commitment serving as the evaluation criteria.

## **DONOR AWARD PROGRAMS**

The Awards may be allocated to one or more students, based on the qualification levels of the responding candidates. Multiple student sponsorships are welcomed.

### **PLATINUM AWARD PROGRAM**

**\$5,000 or more**

Will fund Multiple Scholarships, or an Individual Scholarship with the option of funding subsequent year(s) tuition for the same student who continues to excel in his or her graphic communications program.

### **GOLD AWARD PROGRAM**

**\$1,000 – \$5,000**

Will fund an Individual Scholarship with the option of funding subsequent year(s) tuition for the same student who continues to excel in his or her graphic communications program.

### **SILVER AWARD PROGRAM**

**Less than \$1,000**

Will be combined with other monies to fund various Special Achievement Awards.

## **BENEFITS TO DONORS**

- All donors will be invited to attend the Annual Awards Ceremony located at a select site in New York City.
- All donors will be recognized in the Awards Ceremony Program and invited to present their specially named scholarship at this event.
- Photos and editorial coverage will be distributed to the general news and regional trade media after the Awards Program and throughout the year.
- All Platinum, Gold and Silver donors will be mentioned in year-round distribution of promotional material.
- All Platinum, Gold and Silver donors will be able to honor someone by naming the scholarship after that person, i.e., *In Memory of... In Honor of...* Corporations can assign their company's name to the scholarships, e.g. *XYZ Printing Corp. Scholarship Award*.
- All Platinum, Gold and Silver donors will receive a Certificate of Appreciation.
- Industry associations, groups and clubs may affix their name to a scholarship regardless of the amount given. Accumulated monies will be used to create these special industry recognition awards.
